- Check in and set-up begins @ 9 am until noon. You will receive your site assignment when you register unless we agree to a pre-arranged site.
- Register by the Boyne Area Chamber of Commerce building (Log Cabin)
28 S. Lake St. Boyne City, MI 2 blocks south of Festival Tent at the stop light on Lake Street
- Make sure your display has large-print easy to read signage along the top of tent, identifying your business.
- *This is Michigan with unpredictable weather. Consider temperature, wind, precipitation, and dress appropriately. Be ready for whatever Mother Nature gives us....You are along Lake Charlevoix which leads to Lake Michigan. Plan for the worst...be thankful if it is not.*
- If you have signs and handout materials ...signs should be laminated and handouts securely held down or in stand displays.
- Access via ramp off of side street into park to and from site. Parking off site at a premium.

- Saturday, May 20th 10:00am to 6:00pm
- Sunday, May 21st 11:00am to 4:00pm

1. Display tents with short (12" max stakes only) or cinder blocks with secure roping
